WHAT HAPPENS IF CALAMATTA CUSCHIERI INVESTMENT MANAGEMENT LIMITED IS UNABLE TO PAY OUT?

By law, the fund's assets are not held in custody by the fund management company and each fund must have a specific depositary that handles the safekeeping of the fund's assets. The fund's assets and liabilities are segregated from the assets and liabilities of other subfunds and of the investment manager. As a result, the fund's ability to pay out is not affected by the default of Calamatta Cuschieri Investment Management Itd. In the event of the bankruptcy of the fund management company, the management of the fund is taken over by the depositary (Sparkasse Bank Malta plc). There is no compensation or guarantee scheme for investors in the fund.
